

Terms and Conditions University of Cambridge Inspiring Educator Awards 2023/4

These terms and conditions were last update on 10/10/23

General

- 1. An entry is the completion and submission of an entry form.
- 2. An entry form can only be completed and submitted by University of Cambridge students, who will therefore be the nominators.
- 3. A nominee cannot enter themselves into the Awards.
- 4. By submitting an entry, you agree for the University to hold and use your personal information included with your nomination for the purposes of administering the Educator Award.
- 5. Applications will ONLY be submitted on the official entry form.
- 6. The deadline for receipt of entries is 10.45 Sunday, 5 November 2023.
- 7. Incomplete or late entries will not be accepted.
- 8. No liability for entries lost or delayed will be accepted.
- 9. There is no limit on the number of entries a Student (nominator) may make. Each nominator can only nominate an Educator (nominee) in one award category.
- 10. Nominees must be employed by a state-funded school, sixth form or further education college in the UK.
- 11. Nominations for educators who have retired prior to the granting of the Awards will not be accepted.
- 12. Posthumous nominations will not be accepted.
- 13. The winner will be chosen by a panel of senior staff sourced from the University. Prior to entries being passed to the panel, the Widening Participation and UK Student Recruitment Teams will review the entries in order to remove any inappropriate, incomplete or otherwise invalid entries.
- 14. Nominees will only be judged against the category to which they have been nominated.
- 15. There can be no appeal against the decisions of the judges and these decisions must be accepted as final in respect of all matters concerning the Educator Awards including the interpretation of the rules and conditions of entry.
- 16. The University will automatically contact nominators and nominees when a nomination is submitted in order to:
- 1. Notify the nominator that their submission has been successful.
- 2. Notify the nominee that they have been nominated and to gain the nominee's consent to proceed with the Awards process.

- 17. The University will contact nominators and nominees directly if they achieve a winning nomination.
- 18. The Awards will be publicised on the University website. The University reserves the right to conduct further publicity, including, but not limited to, working with local and national press associations.
- 19. The University reserves the right to withdraw entries from consideration.
- 20. The University reserves the right to withdraw the awards in their entirety.

Prizes:

- 1. The prize will consist of:
- a. The University will fund travel to the University of Cambridge Teachers' and Advisors' Conference taking place in July 2023. Please note that overnight stays are not covered within the remit of this prize, only travel to and from the Conference.
- b. A non-monetary prize certificate.
- c. £300 for the institution by which the winner is employed to spend on IT equipment or books.
- 2. The prize is non-exchangeable, non-refundable and no alternative (cash or otherwise alternative prizes different from those listed in these terms and conditions) is offered. The University of Cambridge reserves the right to substitute the prize with an alternative prize of equal or higher value if circumstances beyond our control deem this necessary
